Principal Activities

The Wesley Music Foundation is a community organisation promoting music and music education. The principal activities of the Wesley Music Foundation during the financial year were the operation of the Wesley Music Centre venue, running of the ACT Organ School, providing music scholarships and undertaking joint ventures with other music organisations.

Significant Changes

No significant change in the nature of these activities occurred during the year.

Operating Result

The consolidated operating result for the financial year was a loss of \$10,841 (the FY12 profit was \$36,089). Note: Without depreciation the profit was \$31,356 (\$79,223 in FY12).

The decrease in profit can be attributed mainly to a decrease in donations from last year's recovering \$77,605 in FY12 to a still pleasing \$66, 661 in FY13. These donations were used for community joint ventures (\$13,871 up from \$1,940) as well as for new pipe organ and other scholarships (\$23,175 up from \$19,135). Other factors were one-off costs associated with the 10th anniversary of the Music Centre in September 2012, including the publication of an anniversary book, the loss of a one-off income from registration fees for a music course in FY12 and an increase in salary payments in FY13. The general high level of activity in the Music Centre increased slightly in FY13.

STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements are special purpose financial statements that have been prepared broadly in accordance the requirements of the *ACT Associations Incorporation Act 1991*.

The financial statements cover the Wesley Music Foundation as an unincorporated entity operating under a Trust.

The financial statements are prepared on an accruals basis and are based on historical costs. They do not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets. The accounting policies have been consistently applied unless otherwise stated.

The following is a summary of the material accounting policies adopted by the Wesley Music Foundation in the preparation of the financial statements. The accounting policies have been consistently applied unless otherwise stated.

Income Tax

The Wesley Music Foundation has an ABN and is registered for GST. The Wesley Music Foundation has received endorsement from the Australian Tax Office as a Charitable Institution with a GST Concession, FBT Rebate and Income Tax Exemption. The Wesley Music Foundation is registered as a Cultural Organisation under the Income Tax Act 1997 S30-15 and is therefore endorsed as a Deductible Gift Recipient and maintains a separate Public Fund for gifts.

The operation of the Wesley Music Centre is conducted as a Non-profit Sub-entity for the purposes of GST. No GST is charged on sales and GST is absorbed on inputs. This operation is recorded in the General Accounts.

Accounting methodology

In FY12 we added a separate set of accounts for "Friends of Wesley Music Memberships" (FOWM) and associated income and expenses, because the ATO specifically prohibits memberships as part of our Public (Gift Deductible Recipient) accounts or as part of our General (Non-profit Sub-entity) accounts.

Assets costing less than \$1,000 are expensed.

Buildings are straight-line depreciated over 40 years and Plant & Equipment over 10 years.

As our bank credit-card merchant facility deposits only to our General accounts, we have transfers of memberships fees and donations from General to the FOWM accounts and also transfers of donations from General and FOWM accounts to the Public accounts.
