The cultural purposes of the Foundation are to promote music, including public performance, music education, the housing of music and the maintenance and development of musical instruments and associated activities.

Wesley Music Foundation

The Wesley Music Foundation is a community cultural organisation set up in 1999 by the Wesley Uniting Church to promote music and music education, and to develop and maintain strong musical programs in perpetuity. It is listed on the Australian Government's Register of Cultural Organisations and is run by its own Board of Management.

The Foundation:

- supports a diversity of activities including concerts, festivals, seminars, workshops, master classes, recordings, music examinations, and the teaching of voice, organ and piano
- has provided scholarships and performance opportunities for young people studying at the ANU School of Music and at ACT secondary and tertiary educational institutions, including those studying voice, keyboard, guitar and orchestral instruments
- established and operates the ACT Organ School focusing on the teaching of pipe organ, especially to young school students
- is responsible for the funding and operation of the Wesley Music Centre, which provides unique and high quality spaces for a variety of music-related activities, including concerts and master classes using a fine Yamaha Grand piano and a unique harpsichord, which is a copy of a French 18th century 2-manual Goujon in the Paris Conservatoire
- made substantial contributions to the cost of rebuilding the Wesley Church organ to the highest international standards from 2000 to 2002
- has established joint ventures with community associations to provide awards for performances, competitions, compositions, master classes and concerts or other public events, including the Canberra String Association, the Canberra Classical Guitar Society, the Carillon Society of Australia and the ACT Keyboard Association
- operates an active Friends of Wesley Music (FOWM) to support the objectives of the Foundation. It offers concessional prices for many other music events. Our subscribers receive regular information on coming events and discounts of around 15% off door prices for events promoted by the Foundation and some other organisations.

How to Support Us

- operate and expand the *ACT Organ School* with additional scholarships

The music scholarship program has already provided about 100 scholarships from 1994 to 2014 for students of voice, piano, pipe organ and other instruments.

The *ACT Organ School* has achieved considerable success in the development of young as well as mature age organists.
